RE: Notice of Acceptance of Proposal and Intent to Award Gilman Springs Road Pavement Rehabilitation Project Soboba Road to East of State Route 79 (Sanderson Avenue/Lamb Canyon Road, San Jacinto Area Project No. C1-0564

Dear Mr. Bradley:

Please consider this as the County of Riverside's notice to your firm that it accepts your proposal received June 12, 2013 for the referenced project, and that the County of Riverside intends to award the construction contract to your firm. The total contract Agreement amount is \$1,695,108.00.

Per Instruction to Bidders Item 12.d (page A4), the County has selected to award the contract Agreement prior to execution by the Contractor. Once the contract Agreement is executed by the Chairman of the Board of Supervisors, we will forward 5 original Agreement documents to your company for signatures. The contract Agreement is anticipated to be approved for award on July 2, 2013. Meanwhile, a copy of contract Agreement that was sent to our Board of Supervisors is attached for your information.

Attached for execution, by your company, is a copy of a Faithful Performance Bond form, and a Payment Bond form.

We request that you initiate preparation of the bonds for the project, in accordance with the contract requirements. Submit two (2) original Faithful Performance Bonds, two (2) original Payment Bonds, and one (1) complete insurance certificate package that conforms to the terms of the bid documents.

Insurance documentation shall include additional insured endorsements for General Liability policies, Automobile Liability policies, and Excess Liability policies. Additionally, a Waiver of Subrogation shall be furnished for the Worker's compensation policy. All endorsements must be signed by authorized broker or insurance carrier. Attached to this letter is a Standard Public Works Contracts Insurance Requirements list.

In addition to the County of Riverside, the additional insured endorsements and waiver of subrogation must name the following:

- 1. Caltrans, its officers, directors, employees and agents.
- 2. City of San Jacinto, its officers, directors, employees and agents.
- 3. Golden Era Productions, its officers, directors, employees and agents.

Also, please provide us with a Corporate Resolution authorizing the signatory of the agreement to sign such documents on behalf of your corporation.

Failure to submit all of the above listed documents to the Transportation Department within the specified time in the special provision may cause the County of Riverside to consider your firm as not being in compliance with the bid documents, resulting in rescission of the Notice of Acceptance and Intent to Award and the pending award approval, and your bid bond being forfeited on that basis.

Following full execution and award of the contract by the County of Riverside Board of Supervisors and your company, your company will be requested return the signed documents. Upon final review and acceptance, one original set of the agreement and bonds will be returned to you for your file.

Attached is a copy of the summary of bids for your use and reference.
