Dear Mr. Medina:

Please consider this as the County of Riverside's notice to your firm that it accepts your proposal received October 29, 2014 for the referenced project, and that the County of Riverside intends to award the construction contract to your firm. The total contract amount is \$507,103.65.

Please note that your company's Bid for the referenced project required corrections in accordance with the Instructions to Bidders, Section 14, "Bids". The bid items that were corrected are items No. 9 and No. 20 since the written unit price prevailed. Additionally, as described in the Decimal Errors paragraph, the unit price for bid item No. 30, "Remove Traffic Stripe and Pavement Markings" has been corrected to the amount of \$0.75. As a result, your total bid amount is corrected from \$507,282.90 to \$507,103.65. A copy of your proposal and the corrected bid summary are attached for your reference.

Per Instructions to Bidders Item 20.D (page A11), the County has selected to award the Contract prior to execution by the Contractor. Once the Contract is executed by the Chairman of the Board of Supervisors, we will forward 4 original contracts to your company for signatures. The Contract is anticipated to be approved for award on December 16, 2014 (Agenda item TBD). Meanwhile, a copy of the Contract, which was sent to County Board of Supervisors for approval and signatures, is attached for your information.

Attached for execution, by your company, is a copy of a Performance Bond form and a Payment Bond form.

We request that you initiate preparation of the bonds for the project, in accordance with the contract requirements. Submit two (2) original Performance Bonds, two (2) original Payment Bonds, and one (1) complete insurance certificate package that conforms to the terms of the bid documents.

Please refer to General Conditions Section 4, "Insurance and Hold Harmless" of the Specifications and Contract Documents Book starting on page GC 4. Insurance documentation must include additional insured endorsements for General Liability policies, Automobile Liability policies, and Excess Liability policies. Additionally, a Waiver of Subrogation shall be furnished for the Worker's compensation policy. All endorsements must be signed by authorized broker or insurance carrier.

The additional insured endorsements and waiver of subrogation must name the following:

1. "The County of Riverside, its elected and appointed officials, employees, agents, and representatives".
2. "The City of Lake Elsinore, its elected and appointed officials, employees, agents, and representatives".

Each of the above listed entities shall also be held harmless, in accordance with the requirements of General Conditions Section 4, "Insurance and Hold Harmless" of the Specifications and Contract Documents Book.

Also, please provide us with a Corporate Resolution authorizing the signatory of the Contract to sign such documents on behalf of your corporation.

Failure to execute the documents and submit all of the above listed documents to the Transportation Department within the specified time may cause the County of Riverside to consider your firm as not being in compliance with the bid documents, resulting in rescission of the Notice of Acceptance and Intent to Award, and your bid bond being forfeited on that basis.

Following full execution and award of the contract by the County of Riverside Board of Supervisors, your company will be requested to return signed Contracts. Upon final review and acceptance, one original set of the Contract, bonds, and copy of acceptable insurance documents will be returned to you for your company's file.

Attached is a copy of the summary of bids for your use and reference.
